The <u>U.S. Department of Justice</u> (DOJ), <u>Office of Justice Programs</u> (OJP), <u>Office of Sex Offender Sentencing</u>, <u>Monitoring</u>, <u>Apprehending</u>, <u>Registering and Tracking</u> (SMART) is seeking applications for funding under the Fiscal Year (FY) 2016 Promoting Evidence Integration in Sex Offender Management: Juvenile Treatment Progress Scale Development and Implementation project. This program furthers the Department's mission by supporting the SMART Office in assisting states, the District of Columbia, territories, and tribal jurisdictions with developing and/or enhancing a program designed to implement the requirements of the Sex Offender Registration and Notification Act (SORNA) of the Adam Walsh Child Protection and Safety Act of 2006, and to promote innovation and best practices in the field of sex offender management.

SMART FY 2016 Promoting Evidence Integration in Sex Offender Management: Juvenile Treatment Progress Scale Development and Implementation

Applications Due: May 9, 2016

Eligibility

Eligible applicants are nonprofit organizations and for-profit organizations (including tribal organizations), individuals, institutions of higher education (including tribal institutions of higher education), faith-based organizations, and community organizations and consortiums with demonstrated experience in the treatment, assessment, and management of juveniles who commit sex offenses. For-profit organizations must agree to waive any profits or fees for services.

The SMART Office welcomes applications that involve two or more entities that will carry out the funded Federal award activities; however, one eligible entity must be the applicant and the other(s) must be proposed as subrecipient(s). The applicant must be the entity with primary responsibility for administering the funding and managing the entire project. Only one application per lead applicant will be considered; however, a subrecipient may be part of multiple proposals.

The SMART Office may elect to make awards for applications submitted under this solicitation in future fiscal years, dependent on, among other considerations, the merit of the applications and on the availability of appropriations.

Deadline

Applicants must register with <u>Grants.gov</u> prior to submitting an application. All applications are due to be submitted and in receipt of a successful validation message in Grants.gov by 11:59 p.m. eastern time on May 9, 2016.

SMART FY2016 Promoting Evidence Integration in Sex Offender Management: Juvenile Treatment Progress Scale Development and Implementation (CFDA #16.203)

A. Program Description

Overview

The Office of Sex Offender Sentencing, Monitoring, Apprehending, Registering and Tracking (SMART) seeks applications for the development and validation of an assessment scale that measures treatment needs for juveniles who have sexually offended and progress toward completion of treatment. This program furthers the work of the SMART Office's Sex Offender Management Assessment and Planning Initiative (SOMAPI), a project designed to assess the state of research and practice in sex offender management and to inform the Office of Justice Programs' research and grant-making efforts in this area. This program is authorized by 42 U.S.C. § 16901, et seq.; Pub. L. No. 114-113, 129 Stat 2242, 2307.

Project-Specific Information

While most individuals who commit sex crimes are adults, a significant number of sex crimes are committed by individuals who are younger than 18 years of age. While juvenile offenders have long been viewed as fundamentally different from adult offenders, the developmental differences between juveniles and adults that have been identified through recent advances in neuroscience and developmental criminology are extensive and profound. Unfortunately, many of the intervention and management strategies for juveniles who commit sexual offenses have not been based on a formal recognition that juveniles are developmentally different from adults. Given the fundamental differences that have been observed between juveniles who commit sexual offenses and adults who commit sexual offenses, it is critically important to distinguish between these two populations when developing programs or policies for treatment, assessment or other interventions.¹

Over the past eight years, the Office of Justice Programs (OJP) has contributed to the knowledge base of risk and needs assessment. In 2008, OJP's SMART Office and National Institute of Justice (NIJ) funded an evaluation of two adult risk assessment tools, Sex Offender Treatment Intervention and Progress Scale (SOTIPS) and the Static-99R, to determine whether the combined use of these tools would result in more accurate risk predictions in the State of Vermont. Results showed that the combined use of these tools improved risk prediction accuracy more than either tool used alone. In 2012, SMART and NIJ funded a replication and evaluation of this model in two additional jurisdictions. And in 2013, SMART and NIJ funded a project to improve knowledge of and the accuracy and efficacy of risk assessment tools in the field of juvenile justice, as there is currently a dearth of knowledge on static and dynamic risk assessments for juveniles who commit sex offenses. Building upon this work, and recognizing

the need for professionals to more objectively measure intervention efficacy with sexually offending youth, this solicitation seeks the development of a juvenile treatment needs and progress assessment scale.

Assessments are administered throughout the criminal and juvenile justice process (i.e., courts, adjudication, disposition, corrections, supervision, and treatment). The point in the process at which an assessment is administered, as well as the purpose of the evaluation, may have significant impact on the evaluation. Within the context of treatment, assessment is typically used to set a baseline assignment of risk and to then periodically reevaluate risk during the course of treatment. In addition, the risk assessment process can be used to determine the type and intensity of treatment needed and to help define targets (i.e., dynamic factors or criminogenic needs) for treatment and case management.² Because dynamic risk factors are potentially changeable, needs assessment instruments offer direction to providers about which problems to target in order to reduce risk to reoffend. Assessing dynamic risk at regular intervals during the course of services may be important in helping providers adjust the intensity and duration of interventions to match youths' changing risk and needs,³ with the ultimate goal of treatment completion.

There is a small to moderate positive effect of treatment on the recidivism rates of juveniles who commit sex offenses. Specifically, juveniles who complete a cognitive-behavioral treatment program are less likely to commit a sexual or nonsexual re-offense than are juveniles who do not receive treatment, receive an alternative treatment, or do not complete treatment. One particularly important meta-analysis study that found positive treatment effects, especially those who completed treatment, was conducted by Winokur and colleagues in 2006. Overall, seven rigorous recidivism studies were included in the meta-analysis. In all seven studies, treatment involved some type of cognitive-behavioral approach. The researchers found that adolescents who completed sexual offender treatment had significantly lower recidivism rates than untreated adolescents and those who failed to complete treatment.

Goals, Objectives, and Deliverables

With this solicitation, the SMART Office seeks applications for funding the development and validation of a dynamic assessment tool for juveniles who commit sex offenses designed for use by professionals in measuring treatment needs and progress toward completion.

The project objectives include:

- Develop and validate a scale that incorporates dynamic (needs) factors that assesses a
 youth's progress in meeting treatment goals and treatment completion.
- Incorporate the scale into a cognitive-behavioral treatment program and train providers on its use.
- Evaluate the implementation, impact and efficacy of incorporating the scale into the treatment program.

Implement the scale in up to two sites and validate the scale in each.

Applicants may validate an assessment scale currently available in the field or develop a tool for the purposes of this solicitation. A justification for the tool selected should be made and included in the proposal.

Site Selection

The assessment scale should be validated in up to two sites that are geographically and demographically diverse. The sites should have a minimum of 300 - 500 youth that can be included in the project. The applicant should provide evidence of the sites' case flow and population of juveniles who have committed sex offenses. The sites should have automated data and information systems in place capable of tracking juveniles who commit sex offenses in the study. Evidence of these data systems and their capabilities should be described in the application. Applicants may include financial incentives in their proposed project budgets to encourage site participation. The sites selected to participate in the project will not receive additional funding from the SMART Office to implement the validated assessment scale or to develop a tool.

Applicants are encouraged to include a Memorandum of Understanding (MOU) or Letter of Intent from each site detailing their commitment to participate in the project in their submitted application. This document should be provided to SMART before an award is made. A special condition will be attached to the award stipulating that the grantee may not obligate, expend, or drawdown any project funds until SMART has received an MOU or Letter of Intent from the participating sites.

The selected grantee will be responsible for the following activities:

- Work collaboratively with the selected sites to incorporate the scale selected or developed for this project into a cognitive-behavioral treatment program and train providers on its use.
- Work with the selected sites to track and document the implementation of the assessment tool.
- Evaluate the implementation, impact and efficacy of incorporating the scale into the treatment program.
- Verify the data infrastructure and data collection capabilities of the selected sites, and provide training on data-related issues, if applicable.
- Report and disseminate interim and final project results.

Project Deliverables and Other Project Activities

The following deliverables will be submitted to the SMART Office at the end of the project period:

A final report and an executive summary that details (1) the development or modification
and validation of the assessment scale, (2) the implementation, impact and efficacy of
incorporating the scale into the treatment program, (3) significant findings, (4) any
significant policy implications and lessons learned, and (5) a general description of the
methods used and activities performed.

 A copy of the treatment needs and progress assessment scale developed for the purposes of the project or the existing tool implemented and validated for the project as well as all corresponding and relevant materials.

Applicants are encouraged to submit a copy of the assessment tool to be used for this project if it has been developed or is in use at the time of application.

Other expected deliverables for this project include:

- Monthly conference calls with the SMART program manager to review progress and address issues.
- Bi-monthly progress reports to keep SMART apprised of the current status of the project.
 Additional information about the content of the progress reports and their due dates will be provided once an award is made.
- A final progress report and a task activity summary will be submitted at the end of the performance period. The task activity summary shall address activities undertaken to achieve completion of this project.
- Data sets resulting from this research will be submitted as a product or deliverable for archiving, if applicable.

Evidence-Based Programs or Practices

OJP strongly emphasizes the use of data and evidence in policy making and program development in criminal justice, juvenile justice, and crime victim services. OJP is committed to:

- Improving the quantity and quality of evidence OJP generates
- Integrating evidence into program, practice, and policy decisions within OJP and the field
- Improving the translation of evidence into practice

OJP considers programs and practices to be evidence-based when their effectiveness has been demonstrated by causal evidence, generally obtained through one or more outcome evaluations. Causal evidence documents a relationship between an activity or intervention (including technology) and its intended outcome, including measuring the direction and size of a change, and the extent to which a change may be attributed to the activity or intervention. Causal evidence depends on the use of scientific methods to rule out, to the extent possible, alternative explanations for the documented change. The strength of causal evidence, based on the factors described above, will influence the degree to which OJP considers a program or practice to be evidence-based. The OJP CrimeSolutions.gov website is one resource that applicants may use to find information about evidence-based programs in criminal justice, juvenile justice, and crime victim services.

B. Federal Award Information

The SMART Office estimates that it will make one award of up to \$500,000 for a 36-month project period, beginning on October 1, 2016.

The SMART Office may, in certain cases, provide supplemental funding in future years to awards under this solicitation. Important considerations in decisions regarding supplemental funding include, among other factors, the availability of funding, strategic priorities, assessment of the quality of the management of the award (for example, timeliness and quality of progress reports), and assessment of the progress of the work funded under the award.

All awards are subject to the availability of appropriated funds and to any modifications or additional requirements that may be imposed by law.

Type of Award⁶

The SMART Office expects that it will make any award from this solicitation in the form of a cooperative agreement, which is a particular type of grant used if the SMART Office expects to have ongoing substantial involvement in award activities. Substantial involvement includes direct oversight and involvement with the grantee organization in implementation of the grant, but does not involve day-to-day project management. See Administrative, National Policy, and other Legal Requirements, under Section F. Federal Award Administration Information, for details regarding the federal involvement anticipated under an award from this solicitation.

Financial Management and System of Internal Controls

Award recipients and subrecipients (including any recipient or subrecipient funded in response to this solicitation that is a pass-through entity⁷) must, as described in the Part 200 Uniform Requirements set out at 2 C.F.R. 200.303:

- (a) Establish and maintain effective internal control over the Federal award that provides reasonable assurance that the recipient (and any subrecipient) is managing the Federal award in compliance with Federal statutes, regulations, and the terms and conditions of the Federal award. These internal controls should be in compliance with guidance in "Standards for Internal Control in the Federal Government" issued by the Comptroller General of the United States and the "Internal Control Integrated Framework", issued by the Committee of Sponsoring Organizations of the Treadway Commission (COSO).
- (b) Comply with Federal statutes, regulations, and the terms and conditions of the Federal awards.
- (c) Evaluate and monitor the recipient's (and any subrecipient's) compliance with statutes, regulations, and the terms and conditions of Federal awards.
- (d) Take prompt action when instances of noncompliance are identified including noncompliance identified in audit findings.
- (e) Take reasonable measures to safeguard protected personally identifiable information and other information the Federal awarding agency or pass-through entity designates as sensitive or the recipient (or any subrecipient) considers sensitive consistent with applicable Federal, state, local, and tribal laws regarding privacy and obligations of confidentiality.

Budget Information

Cost Sharing or Matching Requirement

This solicitation does not require a match. However, if a successful application proposes a voluntary match amount, and OJP approves the budget, the total match amount incorporated into the approved budget becomes mandatory and subject to audit.

Pre-Agreement Cost (also known as Pre-award Cost) Approvals

Pre-agreement costs are costs incurred by the applicant prior to the start date of the period of performance of the grant award.

OJP does not typically approve pre-agreement costs; an applicant must request and obtain the prior written approval of OJP for all such costs. If approved, pre-agreement costs could be paid from grant funds consistent with a grantee's approved budget, and under applicable cost standards. However, all such costs prior to award and prior to approval of the costs are incurred at the sole risk of an applicant. Generally, no applicant should incur project costs *before* submitting an application requesting federal funding for those costs. Should there be extenuating circumstances that appear to be appropriate for OJP's consideration as preagreement costs, the applicant should contact the point of contact listed on the title page of this announcement for details on the requirements for submitting a written request for approval. Limitation on Use of Award Funds for Employee Compensation; Waiver

With respect to any award of more than \$250,000 made under this solicitation, recipients may not use federal funds to pay total cash compensation (salary plus cash bonuses) to any employee of the award recipient at a rate that exceeds 110% of the maximum annual salary payable to a member of the Federal Government's Senior Executive Service (SES) at an agency with a Certified SES Performance Appraisal System for that year.8 The 2016 salary table for SES employees is available at the Office of Personnel Management website. Note: A recipient may compensate an employee at a greater rate, provided the amount in excess of this compensation limitation is paid with non-federal funds. (Any such additional compensation will not be considered matching funds where match requirements apply.) For employees who charge only a portion of their time to an award, the allowable amount to be charged is equal to the percentage of time worked times the maximum salary limitation.

The Assistant Attorney General for OJP may exercise discretion to waive, on an individual basis, the limitation on compensation rates allowable under an award. An applicant requesting a waiver should include a detailed justification in the budget narrative of the application. Unless the applicant submits a waiver request and justification with the application, the applicant should anticipate that OJP will request the applicant to adjust and resubmit the budget.

The justification should include the particular qualifications and expertise of the individual, the uniqueness of the service the individual will provide, the individual's specific knowledge of the program or project being undertaken with award funds, and a statement explaining that the individual's salary is commensurate with the regular and customary rate for an individual with his/her qualifications and expertise, and for the work to be done.

Prior Approval, Planning, and Reporting of Conference/Meeting/Training Costs

OJP strongly encourages applicants that propose to use award funds for any conference-, meeting-, or training-related activity to review carefully—before submitting an application—the OJP policy and guidance on conference approval, planning, and reporting available at www.ojp.gov/financialguide/DOJ//PostawardRequirements/chapter3.10a.htm. OJP policy and guidance (1) encourage minimization of conference, meeting, and training costs; (2) require prior written approval (which may affect project timelines) of most conference, meeting, and training costs for cooperative agreement recipients and of some conference, meeting, and training costs for grant recipients; and (3) set cost limits, including a general prohibition of all food and beverage costs.

Costs Associated with Language Assistance (if applicable)

If an applicant proposes a program or activity that would deliver services or benefits to individuals, the costs of taking reasonable steps to provide meaningful access to those services or benefits for individuals with limited English proficiency may be allowable. Reasonable steps to provide meaningful access to services or benefits may include interpretation or translation services where appropriate.

Limit on Number of Application Submissions

If an applicant submits multiple versions of the same application, the SMART Office will review only the most recent system-validated version submitted. For more information on system-validated versions, see How to Apply.

D. Application and Submission Information

What an Application Should Include

Applicants should anticipate that if they fail to submit an application that contains all of the specified elements, it may negatively affect the review of their application; and, should a decision be made to make an award, it may result in the inclusion of special conditions that preclude the recipient from accessing or using award funds pending satisfaction of the conditions.

Moreover, applicants should anticipate that applications that are determined to be nonresponsive to the scope of the solicitation, or that do not include the application elements that the SMART Office has designated to be critical, will neither proceed to peer review nor

receive further consideration. Under this solicitation, the SMART Office has designated the following application elements as critical: Program Narrative, Budget Detail Worksheet, Budget Narrative, and requested funding amount that does not exceed the maximum amount allowable. Applicants may combine the Budget Narrative and the Budget Detail Worksheet in one document. However, if an applicant submits only one budget document, it must contain **both** narrative and detail information. Please review the "Note on File Names and File Types" under How to Apply to be sure applications are submitted in permitted formats.

OJP strongly recommends that applicants use appropriately descriptive file names (e.g., "Program Narrative," "Budget Detail Worksheet and Budget Narrative," "Timelines," "Memoranda of Understanding," "Résumés") for all attachments. Also, OJP recommends that applicants include résumés in a single file.

1. Information to Complete the Application for Federal Assistance (SF-424)

The SF-424 is a required standard form used as a cover sheet for submission of preapplications, applications, and related information. Grants.gov and the OJP Grants Management System (GMS) take information from the applicant's profile to populate the fields on this form. When selecting "type of applicant," if the applicant is a for-profit entity, select "For-Profit Organization" or "Small Business" (as applicable).

Intergovernmental Review: This funding opportunity (program) is not subject to Executive Order 12372. (In completing the SF-424, applicants are to make the appropriate selection in response to question 19 to indicate that the "Program is not covered by E.O. 12372.").

2. Project Abstract

Applications should include a high-quality project abstract that summarizes the proposed project in 400 words or less. Project abstracts should be—

- Written for a general public audience
- Submitted as a separate attachment with "Project Abstract" as part of its file name
- Single-spaced, using a standard 12-point font (Times New Roman) with 1-inch margins

As a separate attachment, the project abstract will **not** count against the page limit for the program narrative.

All project abstracts should follow the detailed template available at ojp.gov/funding/Apply/Resources/ProjectAbstractTemplate.pdf.

Permission to Share Project Abstract with the Public: It is unlikely that the SMART Office will be able to fund all applications submitted under this solicitation, but it may have the opportunity to share information with the public regarding unfunded applications, for example, through a listing on a web page available to the public. The intent of this public posting would be to allow other possible funders to become aware of such proposals.

In the project abstract template, applicants are asked to indicate whether they give OJP permission to share their project abstract (including contact information) with the public. Granting (or failing to grant) this permission will not affect OJP's funding decisions, and, if

the application is not funded, granting permission will not guarantee that abstract information will be shared, nor will it guarantee funding from any other source.

Note: OJP may choose not to list a project that otherwise would have been included in a listing of unfunded applications, should the abstract fail to meet the format and content requirements noted above and outlined in the project abstract template.

3. Program Narrative

The program narrative must respond to the solicitation and present a detailed description of the purpose, scope, goals and objectives of the proposed project. The program narrative must be double-spaced, using a standard 12-point font (Times New Roman is preferred) with 1-inch margins, and must not exceed 25 pages. Please number pages "1 of 25," "2 of 25," etc. If the program narrative fails to comply with these length-related restrictions, the SMART Office may consider such noncompliance in peer review and in final award decisions. Submissions that do not adhere to the format will be deemed ineligible.

The following sections should be included as part of the program narrative:

a. Statement of the Problem

Applicants must describe the existing challenges and/or complexities in measuring treatment needs and progress in completing treatment for juveniles who commit sex offenses. Discussion should highlight the issues associated with working with this population, including a synopsis of research literature, existing measurement tools, treatment efficacy, recidivism outcomes, and a description of the demographics, offender population, services available to these youth, and outcome data in the sites intended to be selected in validating the scale.

b. Project Design and Implementation

Applicants must detail how the project will operate during the funding period, align resources to effectively and efficiently implement the proposed project design, and describe the strategy that will be used to implement the proposed project, including project goals and objectives. This section should illustrate what phases and activities are proposed for the project, site selection and implementation of the scale, validation activities, and a description of how the strategy will support the overall goals and objectives. Applicants should include a project timeline, and identify staff responsible for each major task. The key staff performing these responsibilities and percentage of time that they dedicate to these activities should be clearly noted within the budget details worksheet.

c. Capabilities and Competencies

Applicants must document their experience and capabilities to implement the project and the competencies of the staff assigned to the project. This section should include: a description of the management structure and staffing of the project and include information that describes the roles and responsibilities of key organizational and functional components and personnel. Performance measures are included as an alert that the SMART Office will require successful applicants to submit specific data as part of their reporting requirements. Applicants should include the table as a separate attachment to their application. The file should be named "Disclosure of Pending Applications."

Applicants that do not have pending applications as described above are to include a statement to this effect in the separate attachment page (e.g., "[Applicant Name on SF-424] does not have pending applications submitted within the last 12 months for federally funded grants or subgrants (including cooperative agreements) that include requests for funding to support the same project being proposed under this solicitation and will cover the identical cost items outlined in the budget narrative and worksheet in the application under this solicitation.").

e. Research and Evaluation Independence and Integrity

If a proposal involves research and/or evaluation, regardless of the proposal's other merits, in order to receive funds, the applicant must demonstrate research/evaluation independence, including appropriate safeguards to ensure research/evaluation objectivity and integrity, both in this proposal and as it may relate to the applicant's other current or prior related projects. Grants.gov is designed to forward successfully submitted applications to the OJP Grants Management System (GMS).

GMS does not accept executable file types as application attachments. These disallowed file types include, but are not limited to, the following extensions: ".com," ".bat," ".exe," ".vbs," ".cfg," ".dat," ".db," ".dbf," ".dll," ".ini," ".log," ".ora," ".sys," and ".zip." GMS may reject applications with files that use these extensions. It is important to allow time to change the type of file(s) if the application is rejected.

All applicants are required to complete the following steps:

OJP may not make a federal award to an applicant organization until the applicant organization has complied with all applicable DUNS and SAM requirements. Individual applicants must comply with all Grants.gov requirements. If an applicant has not fully complied with the requirements by the time the federal awarding agency is ready to make a federal award, the federal awarding agency may determine that the applicant is not qualified to receive a federal award and use that determination as a basis for making a federal award to another applicant.

Experiencing Unforeseen Grants.gov Technical Issues

Review Process

OJP is committed to ensuring a fair and open process for awarding grants. The SMART Office reviews the application to make sure that the information presented is reasonable, understandable, measurable, and achievable, as well as consistent with the solicitation.

Peer reviewers will review the applications submitted under this solicitation that meet basic minimum requirements. For purposes of assessing whether applicants have met basic minimum requirements, OJP screens applications for compliance with specified program requirements to help determine which applications should proceed to further consideration for award. Although

program requirements may vary, the following are common requirements applicable to all solicitations for funding under OJP grant programs:

- Applications must be submitted by an eligible type of applicant
- Applications must request funding within programmatic funding constraints (if applicable)
- Applications must be responsive to the scope of the solicitation
- Applications must include all items designated as "critical elements"
- Applicants will be checked against the System for Award Management (SAM)

The SMART Office may use internal peer reviewers, external peer reviewers, or a combination, to assess applications meeting basic minimum requirements on technical merit using the solicitation's selection criteria. An external peer reviewer is an expert in the subject matter of a given solicitation who is not a current DOJ employee. An internal reviewer is a current DOJ employee who is well-versed or has expertise in the subject matter of this solicitation. A peer review panel will evaluate, score, and rate applications that meet basic minimum requirements. Peer reviewers' ratings and any resulting recommendations are advisory only, although their views are considered carefully. In addition to peer review ratings, considerations for award recommendations and decisions may include, but are not limited to, underserved populations, geographic diversity, strategic priorities, past performance under prior the SMART Office and OJP awards, and available funding.

OJP reviews applications for potential discretionary awards to evaluate the risks posed by applicants before they receive an award. This review may include but is not limited to the following:

- 3. History of performance
- 4. Reports and findings from audits
- 5. The applicant's ability to effectively implement statutory, regulatory, or other requirements imposed on award recipients
- 6. Proposed costs to determine if the Budget Detail Worksheet and Budget Narrative accurately explain project costs, and whether those costs are reasonable, necessary, and allowable under applicable federal cost principles and agency regulations

Absent explicit statutory authorization or written delegation of authority to the contrary, all final award decisions will be made by the Assistant Attorney General, who may consider factors including, but not limited to, peer review ratings, underserved populations, geographic diversity, strategic priorities, past performance under prior SMART Office and OJP awards, and available funding when making awards.

Recipients will be required to log in; accept any outstanding assurances and certifications on the award; designate a financial point of contact; and review, sign, and accept the award. The award acceptance process involves physical signature of the award document by the authorized representative and the scanning of the fully-executed award document to OJP.

Upon grant approval, OJP electronically transmits (via GMS) the award document to the prospective award recipient. applicant, or for other reasons it determines necessary to fulfill the goals and objectives of the program.

Recipients must submit quarterly financial reports, select semi-annual progress reports, final financial and progress reports, and, if applicable, an annual audit report in accordance with the Part 200 Uniform Requirements. Future awards and fund drawdowns may be withheld if reports are delinquent.

Special Reporting requirements may be required by OJP depending on the statutory, legislative or administrative obligations of the recipient or the program.
